TERMS AND CONDITIONS

1. The tender shall be for the full quantity of all or any of the item(s) as described in the schedule of requirement. The format for price bid is specified in **Annexure- I & Annexure- II**, which should be used at the time of submission of tender. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
2. The rate of GST and any other local taxes should be clearly mentioned separately in the price sheet.
3. Each bidder shall submit only one bid and the L1 bidders should provide the sample of all the goods before giving work order. If the sample is as per specification then the work order will be given to L1, but if the sample is not up to the mark the work order will be given to L2 bidder and L2 bidder provide the sample and the sample is as per specification.
4. Tenders shall remain valid for a period not less than **45 days** from the date of Opening of the bid.
5. Notwithstanding the above, the purchaser reserves the right to accept or reject any bid(s) and to cancel the bidding process at any time prior to the issue of Purchase Order.
6. The purchaser reserves the right at the time of placement of purchase order to increase or decrease the required quantity depending upon demand and supply situation during award of contract period.
7. The delivery should be completed within **15** days from the date of receipt of the confirmed purchase order at consignee placed.
8. Any delay by the supplier in the delivery of the items shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part thereof subject to a maximum of 10% of purchase order value which will be deducted from the payment due.
9. Before delivery the selected firm will be informed to this office for post-delivery Inspection if required, Delivery will not be made if the materials are not as per the specifications.
11. Payment will be made only after submission of bills along proof of delivery (PoD) from the respective consignee places.

16. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

17. Any legal dispute arising out of this is subject to Hazaribagh jurisdiction only.
