Applications are invited for the position of Programme Executive (PE) under the Social Audit Unit (SAU), set up within Jharkhand State Livelihood Promotion Society (JSLPS).

Under Rule 4 of Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Audit of the Schemes rules, 2011, requires Government of Jharkhand to identify or establish independent organization, "Social Audit Unit" (SAU) to facilitate conduct of the Social Audit of MGNREGA works. Government of Jharkhand has decided to in-house the SAU within JSLPS, society under Rural Development Dept and capacitating the SAU for conducting the Social Audit of other Rural Development Schemes as well. JSLPS is in process of recruitment of personnel for Social Audit Units. Details of the position are as follows:
